



# Terms and conditions

## Altro's Magnificent 7 hoodie giveaway

### 1. The Promoter

The promoter is: Altro Limited of Works Road, Letchworth Garden City, Hertfordshire SG6 1NW.

### 2. The prize draw

- 2.1 The title of the prize draw is Altro's Magnificent 7 hoodie giveaway.
- 2.2 Customers who upload any Altro floor installation image, stating which Altro flooring product it is and tagging Altro either by Facebook or LinkedIn, are automatically entered into a monthly prize draw to win one of twenty Altro Magnificent 7 hoodies (each month). Altro hoodies will be awarded on the first working week of each month and are subject to availability.
- 2.3 Altro will contact the prize-draw winners using the direct message option via the social media platform used to upload the image – either Facebook or LinkedIn, to obtain the name and address of where to send the hoodie to.
- 2.4 Hoodies will be sized, and options will be offered to winners, but exact size choice is subject to availability.
- 2.5 You agree that images entered into the prize draw will be displayed on Altro's LinkedIn and Facebook pages (and we may also make your images available on our website and any other media for marketing and/or publicity purposes).

- 2.6 Images should not have any customer branding visible.

### 3. How to enter

- 3.1 The prize draw promotion will run from 00:01 on Wednesday 1 April 2026 (the "Opening Date") to 23:59 on Tuesday 30 June 2026 (the "Closing Date") inclusive.
- 3.2 All entries will automatically be received by the Promoter by uploading Altro flooring installation images via either Facebook or LinkedIn as set out in clause 2.2 above by no later than the Closing Date. All prize draw entries received after the Closing Date are automatically disqualified.
- 3.3 There are three monthly prize draws overall, with winning entries being drawn from entries received between the monthly opening and closing dates set out below. Entries are not rolled over to following months.

- 3.4 Enter the prize draw by tagging Altro in a picture of your completed Altro flooring installation either by via Facebook @AltroLtd or LinkedIn @Altro Limited.
- No purchase necessary.
- 3.5 The monthly prize draw entries will be selected at random from an online randomiser and winners will be advised via the direct messaging channel of the social media platform on which the image was uploaded, during the first working week following the prize draw.

#### **4. Eligibility**

- 4.1 The prize draw is only open to all residents in the UK and Republic of Ireland, aged 18 years or over, except:
- (a) employees of the Promoter or its holding or subsidiary companies;
  - (b) employees of agents or suppliers of the Promoter or its holding or subsidiary companies, who are professionally connected with the prize draw or its administration; or
  - (c) members of the immediate families or households of (a) and (b) above.
- 4.2 The Promoter may require you to provide proof that you are eligible to enter the prize draw.
- 4.3 The Promoter will not accept prize draw entries that are:
- (a) automatically generated by computer;
  - (b) completed by third parties or in bulk;
  - (c) incomplete.
- 4.4 Multiple entries per person/per company are allowed, i.e. a school can have multiple entries for different classrooms, hallways, reception areas – but not multiple entries for the same area i.e. multiple of the same classroom (unless the flooring is different and it cannot be captured all in one photo)
- 4.5 The Promoter reserves all rights to disqualify you if your conduct is contrary to the spirit or intention of the prize draw.

#### **5. The prize**

- 5.1 Each of the twenty monthly winners of the prize draw shall receive a Altro Magnificent 7 hoodie, subject to size availability. There is no cash alternative for the prize.
- 5.2 The prize is not negotiable or transferable.
- 5.3 In order to accept the prize you must, upon notification by the Promoter as set out in clause 2.3, reply via direct message confirming acceptance of the prize, within 14 days. If you do not claim the prize within 14 days of receiving this notification, your claim will become invalid.
- 5.4 The Promoter will make all reasonable efforts to contact the winner. If the winner cannot be contacted or is not available, or has not claimed their prize within 14 days of notification, the Promoter reserves the right to offer the prize to the next eligible entrant.
- 5.5 The prize will then be delivered to the address as advised via the social media direct messaging channel, within 14 days of the confirmed acceptance.

#### **6. Winners**

- 6.1 The decision of the Promoter is final, and no correspondence or discussion will be entered into.
- 6.2 The Promoter will contact the winners personally as soon as practicable after the draw date, using the social media direct messaging channel linked to the entry.

#### **7. Limitation of liability**

While nothing in these terms and conditions will limit or exclude the Promoter's liability for death or personal injury caused by its negligence or for fraud, the Promoter will not be legally responsible to entrants or winners for any losses that were not foreseeable to the Promoter or to the entrant at the time of entry to the promotion or which are caused by a third party.

- 9.2 The Promoter reserves the right to hold void, suspend, cancel, or amend the prize draw where it becomes necessary to do so.
- 9.3 These terms and conditions shall be governed by English law, and the parties submit to the non-exclusive jurisdiction of the courts of England and Wales.
